### **Rodeo Grounds Policy**

## POLICY STATEMENT: To use the rodeo arena, you must:

- 1. Become a member of the Ag Society
- 2. Follow and enforce all bylaws, rules and regulations of the Ag Society
- 3. The Vauxhall Ag Society recommends that everyone using the Rodeo Grounds get a membership with the Alberta Equestrian Federation or other insurance provider
- 4. Schedule use through our arena coordinators:

Please text or call prior to riding at rodeo grounds as part of our safety policy

- 5. Sign waiver-releasing the Ag Society of liability in case of an accident
- 6. Consider volunteering at events held at the Rodeo Grounds

### **RULES AND REGULATIONS:**

- 1. Registration fee must be paid to use the facilities
- 2. You are responsible for locking up after each use; gate code must not be given to non-members
- 3. Barrels and other equipment must be stored properly
- 4. All garbage and litter must be picked up after each use; please use respect
- 5. Any youth **<u>under the age of 16</u>** must be accompanied by a parent or guardian
- 6. All riders entering the arena acknowledge that they are riding at their own risk
- 7. Conduct and practise good horsemanship; **abuse of animals will not be tolerated**
